WHEREAS, this Resolution was considered in open session on the 28<sup>th</sup> day of November, 2022.


NOW, THEREFORE, BE IT:

New home construction	\$4,000.00 <sup>1, 2</sup>
Attached accessory dwelling unit (with an increase in s.f.)	\$1,000.00 <sup>3</sup>
Attached accessory dwelling unit (with no increase in s.f.)	\$ 0.00
Detached accessory dwelling unit	\$2,000.00 <sup>2</sup>
Other addition or accessory structure (more than 400 s.f.)	\$1,000.00 <sup>2</sup>
Other addition or accessory structure (201 to 400 s.f.)	\$ 500.00
Other addition or accessory structure (up to 200 s.f.)	\$ 100.00
Porch or deck	\$ 100.00
Stoop or steps	\$ 75.00
Fence or wall	\$ 50.00
Permit extension	25% of original permit fee
Permit amendment	\$ 300.00
Demolition permit (fee for main building only; no fee for anything else) (Art. 3)	\$ 300.00
Street and sidewalk (Art. 17)	\$ 100.00
Gas line connection (Art. 17)	\$ 300.00
Dumpster (Art. 3)	\$ 75.00
Portable storage unit (Art. 3)	\$ 75.00
Heavy equipment (Art. 3)	\$ 75.00
Street obstruction (Art. 17) (requiring a bond)	\$ 75.00
Street obstruction (Art. 17) (not requiring a bond)	\$ 0.00
Any other item not otherwise specified	\$ 25.00
